Please complete the attached application and return it along with any required documents and a check for fifty dollars (\$50.00) for a new business and twenty-five (\$25.00) for renewal of a license, made payable to the "City of Westphalia". All licenses expire on March 31st of each year.

Please print or type, using black ink. All questions must be answered. If a question is not applicable, indicate "n/a".

Any license applied for will be issued only upon compliance by the applicant with all provisions of City Ordinance 02-20 and the City of Westphalia Zoning Code.

THE FOLLOWING DOCUMENTS MUST BE SUBMITTED WITH YOUR APPLICATION:

State of Missouri Business/Merchants/Retail Sales License and Missouri Department of Revenue No Tax Due Statement (2 separate documents). All businesses that collect sales tax must submit a copy of their State license showing that the business is registered to collect tax inside the city limits of Westphalia. Section 144.083.2 RSMo, "The possession of a retail sales license and a statement from the **Department of Revenue that the licensee owes no tax due under sections 144.010 to 144.510 or sections 143.191 to 143.261, RSMo.**, shall be a prerequisite to the issuance or renewal of any city or county occupation license or any state license which is required for conducting any business where goods are sold at retail." This was effective January 1, 2009. You can get information on obtaining a license by calling Department of Revenue at (573) 751-2836 or on-line at www.dor.state.mo.us/tax.

Osage County Business/Merchants License. Business owners are required by §150.100 RSMo., 2000, to have a county Merchant's License if the Missouri Department of Revenue issues your business a State Sales Tax Number. This is the ONLY prerequisite for obtaining the county license.

Occupancy Permit issued by the appropriate Fire Protection District confirming that the building has met the current Fire Code for the operation of a business.

Health Inspection Report issued by the Osage County Department of Health for any business that requires a Health Inspection Report, such as food service, hotel and lodging, childcare, etc.
